ADDITIONAL INFORMATION ON DATA PROCESSING

In accordance with General Regulation No. 2016/679 on Data Protection, the Women's American Football Team Association - Sports Club Warsaw Sirens informs that:

- The administrator of your child's personal data is the Women's American Football Team Association - Sports Club Warsaw Sirens, hereinafter referred to as the "Association", with its registered office at 00-842 Warsaw, ul. Łucka 15/703, email: kontakt@warsawsirens.pl, website: www.warsawsirens.pl.
- Your child's personal data will be processed for purposes related to the statutory activities conducted within the association in accordance with Art. 6(1)(a) of GDPR and may be shared with other recipients.
- Your child's personal data, including their image (photos and videos), will be processed for the duration of their participation in the project, as well as for the time necessary to achieve the promotional and statutory objectives of the Warsaw Sirens Club, but no longer than until the withdrawal of consent. Withdrawal of consent will not affect the lawfulness of the data processing carried out before its withdrawal or the use of already published materials.
- You have the right to request from the administrator access to personal data, the right to rectify, delete or limit the processing, as well as the right to withdraw consent.
- You have the right to lodge a complaint with the supervisory authority, which is the Office for Personal Data Protection.
- Providing personal data is a statutory requirement and is mandatory due to the provisions of the Act of April 7, 1989, Law on Associations (Journal of Laws 2017.210 consolidated text as amended), and in other respects is voluntary.
